### **DESIGNATED SCHOLARSHIP INFORMATION**

1. The designated scholarship can be set up in the name of a person, family, business, or other entity. Your contribution can also be anonymous.
2. The minimum donation amount for a designated scholarship is \$10,000. There is no limit on the maximum amount of a donation.
3. Scholarship donation paperwork must be filed by November 1st for student spring awarding and fall usage. Scholarship monies must be received no later than December 31.
4. The donor determines the longevity of their scholarship.
5. Scholarship awards can be split between semesters.
6. Donors will receive notification and a thank you letter.
7. If there are no qualified candidates, the money will carry over the next year's process.
8. Relatives of a designated scholarship donor are ineligible for that particular scholarship.
9. The ACA Scholarship Trust Committee determines the scholarship winners.
10. Student are made aware of scholarship opportunities through ACA Scholarship Website at [acascholarshiptrust.org](http://acascholarshiptrust.org).
11. All donations are tax deductible according to 501 (c ) (3) in the United States).

- Grade Point Average (GPA)
- Undergraduate degree program
